Geese...“aplenty”

Many people have asked what actions are being taken to discourage the geese from making our recreational lake their home.

After talking to the State of Illinois biologist, we learned that the geese today have been reclassified: Migratory geese and Residential Geese (non-migratory). Above all, the biologist discourages the intentional of feeding of the geese, which encourages them to give up their natural instinct to migrate. The environmental conditions of plenty of open water (due to “global warming” of the lake not freezing over), plenty of food sources (natural and human provided), and the lack of predators (fox, coyotes) encourage the geese to become Residential (non-migratory) fowl.

For humans, this presents health hazards of polluted water (each goose produces 3 pounds of fecal matter per day on average) and aggressive behavior towards children and adults, especially when goslings are present. Many North Pointe residents have complained about the geese fecal matter around the lake and their aggressive behavior, causing some residents to stop using the lake sidewalk for exercise & leisure.

Following the law, the lake volunteers have tried to discourage the geese with “goose denier” buoys (very modest success), black plastic chain at the water edge (modest success), floating plastic swans (no success), remote control “speed boats” (successful but only when geese in the water without lasting effect), patching gaps in the chain link west bound-

ary fencing (successful when goslings are pre-flight stage of development), and asking neighbors NOT TO FEED ducks or other fowl (no success).

The State of Illinois biologist recommends planting tall growing species of grasses and plants on the lake perimeter. Geese do not locate on lakes with tall growth at the water’s edge in case predators are in hiding to attack them or their young. This is a last resort as per the current NPPOA policy but may be the final solution.

This matter will be discussed at each general meeting of the NPPOA membership. All residents/members are encouraged to provide input to the board (your representatives) as to the desired solution, discussion of alternatives, etc.

Grounds Maintenance Committee

The Multi-Year Project to Trim—Remove—Plant new pine trees continues. Colorado Blue Spruces trees were planted along Ft. Jesse. this spring. Three varieties of pines and spruces will be planted this fall/winter. This is to replace the pine trees that were removed west of the lake. Tree trimming and cutting will continue once bids are received. This will be along Ft. Jesse, west of the lake, and the detention basin. Hopefully the weather will cooperate to get it all done.

As the Austrian Pines continue to deteriorate due to age and disease, current plans are to continue to cut and replace those trees as the budget allows. This will be a continuous effort.

We were able to get the water

draining better through the detention basin which helped dry out that area for mowing and maintenance. More work is planned in the detention basin area so that we can monitor the situation better.

The island at the intersection of Ft. Jesse and North Pointe Dr. was upgraded. Thank you to Susan Crumbaugh, master gardener and a NPPOA board member, for leading this task.

If you see some tree cutting and trimming activity in your area, please be aware. This inconvenience will result in a better looking North Pointe subdivision, which you will be proud to call home.
