Budget Highlights

Due to the ongoing Covid19 pandemic, the November 12 NPPOA board meeting will again be open to board members only. The budget for 2020 will be reviewed and the 2021 budget will be adopted. (The budget numbers in detail are on the last page of the newsletter) Here are some highlights:

- The income for our homeowners association comes from dues payments.
- The budget for 2020 is \$66,040. Based on projections we will be slightly under budget for the year.
- The largest expense is for maintenance of the grass around the lake and the common areas. That is roughly 42% of the total budget.
- The next largest budget item is tree removal, tree trimming, and tree planting.

A few budget items you might not be aware of include:

- Having the dam (west side of the lake) inspected every year at a cost of around \$1200.
- The detention basins need periodic cleaning and for that we budget \$2000 annually.
- Landscaping along College Ave and mulch for all lake and common areas total about \$12,000.

The 2021 budget will be very similar to the 2020 budget.

The foot traffic around the lake and the detention has increased greatly from the virus outbreak. We are thankful that we have places for our home-bound workers and children to enjoy and take a break. We have received a number of positive comments and suggestions for things that continually need to be updated. I think one of the benefits of the foot traffic has been disturbing the geese in their patterns and they are spending less time around the lake, so less mess!

Bids requests have been sent out for the removal of 20 trees and some stumps, mainly around the lake. These trees are scattered across the common properties (you may have noticed the pink ribbons on the trees and stumps). Our plan is to remove the trees in Nov, Dec or early January. One of the main reasons is to avoid damage to property and grass in the colder, dryer weather. So be aware, the activity could be close to you.

Some of the trees being removed are blue spruce. The Blue Spruce has gotten a disease from the white pine beetle and the tops are dying. Look at the two Spruces by the middle dock on the lake.

The trees budgeted for this year will be planted sometime after Nov. 1. Some of the varieties that maybe planted could include: Norway Spruce, White Pine, Black Hills Spruce or Douglas Fir. We plan to add a few deciduous trees to the mix, mainly along the tree line on the dam. If you have a new tree planted close to your location, the NPPOA Board would appreciate if you would assist that new tree by watering it a couple times a week until the ground freezes. Let me know if you can assist.

Attention to the detention basin over the past few years has significantly improved the drainage. This to clean out the lower and upper drain from the detention basin dam. Our plan is to alternate between the
